3. HAZARDS IDENTIFICATION

***** EMERGENCY OVERVIEW *****

Component 1, 2, 3, 5, 7 and 8 – Occupational exposure presents little or no health hazard.

Potential Health Effects:

Eye: Can cause moderate irritation, tearing and reddening, but not likely to permanently injure eye tissue. Can cause severe irritation. Eye contact may result in corneal injury. Symptoms may include discomfort or pain, excess blinking and tear production, with marked redness and swelling of the conjunctiva. Temporary vision impairment (cloudy or blurred vision) is possible.

Skin: Can cause moderate skin irritation, defecting, and dermatitis. Not likely to cause permanent damage. May cause allergic skin reaction.

Inhalation: Can cause minor respiratory irritation, dizziness, weakness, fatigue, nausea, and headache. No toxicity expected from inhalation.

Ingestion: Mildly irritating to mouth, throat, and stomach. Can cause abdominal discomfort. Ingestion of this product may result in central nervous system effects including headache, sleepiness, dizziness, slurred speech and blurred vision. Harmful if swallowed. May cause systemic poi.

4. FIRST AID MEASURES

Do not direct a water stream directly into the hot burning liquid. Use water spray/fog for cooling.
